



# Parent/Player Agreement

Upon accepting a position on a hockey team within one of the Pooled Divisions of the Don Johnson Hockey League (DJHL), the player ("Player") and the player's parent or guardian ("Parent") agree to the following for the upcoming hockey season:

If also playing on a regional AAA team, acknowledge that the player's DJHL team takes precedence over the AAA team and that they must remain in good standing with the DJHL to participate in any AAA hockey.

Players must be well behaved during any and all team related activities where they represent the DJHL. While not limiting a coach's right to discipline a player, behavior which is judged by the Disciplinary Committee to be unacceptable may result in the player being disciplined.

Players and Parents shall treat opposing players, coaches, game officials and others with respect and show good sportsmanship at all times.

Players must behave themselves at all times, particularly when they are together as a team in the dressing room. Foul language, bullying, destruction of rink property, and other inappropriate behavior will not be tolerated and, therefore, grounds for suspension and/or other discipline.

ANY BEHAVIOR WHICH IS JUDGED BY THE DISCIPLINARY COMMITTEE TO BE ABUSIVE OR INTIMIDATING TOWARD A COACH, PLAYER, PARENT, DJHL OPERATING COMMITTEE MEMBER, GAME OFFICIAL, OR OTHERS, SHALL BE DEALT WITH SEVERELY AND MAY RESULT IN THE PLAYER, PARENT OR FAMILY MEMBER BEING SUSPENDED FROM ALL ACTIVITY WITH THE DJHL AND THE FUTURE REFUSAL TO REGISTER ANY MEMBER OF THAT FAMILY.

Parents agree to allow the volunteer coaches to perform their duties to the best of their ability and not openly criticize their coaching or undermine their authority.

Parents wanting a discussion with members of the coaching staff should arrange for an appointment through the Team Manager. At no time should coaches be approached in the rink before, during or after team practices and games by parents to discuss matters related to individual players.

Players are required to participate with their team in the HNL Provincial Tournament. Failure to fulfill this requirement will result in being prohibited from participating in the DJHL or Doug Marshall Hockey League in the following season.

If a Player fails to complete the hockey season for a reason other than illness, injury, or due to an extraordinary circumstance deemed valid by the DJHL President, that Player will be prohibited from participating in the DJHL or the Doug Marshall Hockey League in the following season.

Player will attend all practices, games and team functions unless excused in advance by the coaching staff.

Players acknowledge that they may be videotaped or photographed on behalf of the DJHL for promotional purposes and hereby grant permission to the DJHL to use this videotaped or photographed material at its sole discretion, and I waive all personal rights, claims, and objections arising from DJHL's use of such material in perpetuity.

Team jerseys are the **property of the DJHL** and players will be responsible for the cost of any damage incurred while the uniform is in their possession and can only be worn at approved team games and functions. All players are required to carry their Scotiabank Bantam and Pee Wee A jerseys in a garment bag, separate from their equipment bag, so that the jerseys will not be placed at risk of damage by equipment such as skates or by liquids.

Players must wear all the equipment as specified and required by Hockey Canada and Hockey Newfoundland and Labrador while on the ice or bench during games and practices.

Payment of fees is to be made in a timely fashion as established by the DJHL Operating Committee.
